## Health camp at CCI

We organized Mega Health camp at Sanrakshan Rainbow Home on 10th March 2024 with the support of youth for seva, by inviting 7 General Physician, 7 Dental Doctor and 2 pediatricians for screening all the children. Addition to the screening we had also examined the Haemoglobin level among children and marked their blood Groups. Team of doctors conducted Menstrual Hygiene sessions for Senior Children and Hygiene and cleanliness practices session to Junior Children.

## Viral Marking

We invited medical team from Urban Primary Health Centre (UPHC), Manjunath Nagar and examined HIV test for all the children of Sanrakshan Rainbow Home. By this we completed Viral markings of the each child staying in the residential Care Unit.

## Health Camp at RCCLC

We organised the Health Camp at Community Care Learning Centre, Rayasandra on 16th March 2024, which aimed to provide essential healthcare services and raise awareness about preventive measures among the community members. It was organized in collaboration with Doctors for Seva to address the healthcare needs of the community Children.

Total 18 health Care providers screened the children with various conditions like Dental, Dermatology, Gynecologist, General Health Checkup, Blood Group Identification and Hemoglobin test was done.

In addition to that team also gave an Health Education Session on Genital Health for Boys and Menstrual Health for girls..
